

Pre-Flight Agreement

Passenger Liability Release, Waiver, Discharge and Covenant Not to Sue

This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively, "Release"), made voluntarily by me, the undersigned Releasor, on my own behalf, and on behalf of my heirs, executors, administrators, insurance companies, legal representatives and assigns (hereinafter collectively, "Releasor," "I" or "me" to ATech Designs, LLC, Karl R. Leinsing and The Leinsing Trust (collectively "Releasees"). As the undersigned Releasor, I fully recognize that there are dangers and risks to which I may be exposed by flying in a helicopter (the "Activity" including but not limited to ground instruction, aircraft operation, riding in aircraft at any phase of operation, aircraft exit, rescue operations or attempts, ground or air transportation or operation in any vehicle, use of equipment, or any activity whatsoever incident to the operation thereof). As the undersigned Releasor, I understand that Releasees do not require me to participate in this Activity, but I want to do so despite the possible dangers and risks and despite this Release. With informed consent, and for valuable consideration received, as the undersigned Releasor, I agree to assume and take on myself all of the risks and responsibilities in any way arising from or associated with this Activity, and I release Releasees and all of their affiliates, officers, directors, principals, trustees, legal representatives, members, owners, employees, agents, heirs, beneficiaries, administrators, assigns, and contractors from any and all claims, demands, suits, judgments, damages, actions and liabilities of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, that I may suffer at any time arising from or in connection with the Activity, including any injury or harm to me, my death, or damage to my property (collectively "Liabilities"), and I agree to defend, indemnify, and save Releasees harmless from and against any and all Liabilities. As the undersigned Releasor, I voluntarily assume all risk of personal injury or death sustained during this Activity. I recognize that this Release means I am giving up, among other things, all rights to sue Releasees for injuries, damages or losses I may incur. I also understand that this Release binds my heirs, executors, administrators, legal representatives and assigns, as well as myself. I also affirm that I have adequate medical or health insurance to cover any medical assistance I may require. I affirm that I am personally responsible for all costs associated with medical treatment or property damage that I may incur. I agree that this Release shall be governed for all purposes by New Hampshire law, without regard to such law on choice of law. I have read this entire Release. I fully understand the entire Release and acknowledge that I have had the opportunity to review this Release with an attorney of my choosing if I so desire, and I agree to be legally bound by the Release.
